This form may be used by any individual who is currently serving, or has formerly served, as an active duty member of the Armed Forces of the United States, or a spouse or surviving spouse of such member who was married to the member during a period of active duty, to request a waiver of the initial registration fees. This waiver request is subject to approval by the West Virginia Board of Architects and <u>must be attached to your application for registration</u>.

- Provide a DD-214, NGB-22, DD-1300 or copy of military orders.
- Spouses and Surviving Spouses must also provide a copy of your marriage certificate to the military service member.

Military Service Experience Verification This application is for any veteran honorably discharged applying for registration as an architect to establish their years of military service for purpose of waiving the initial registration fees. **This form must be attached to your application for registration**.

• Provide a DD-214 or NGB-22 showing an honorable discharge.
